Funding for the Perkins grant is provided through Title I of the Carl D. Perkins Career and Technical Education Act of 2006. Funds are provided to the State Board for Community and Technical Colleges (SBCTC) through the Workforce Training and Education Coordinating Board (WTECB) from the U.S. Department of Education under CFDA 84.048.

2019-20 Perkins Fiscal Guidelines - SBCTC

As a condition of accepting Perkins funding, Grant recipients are required to establish and maintain a Perkins Local Advisory Council (LAC). The primary goal of the Council is to review data and information to ensure that programs offered at the institution address current and anticipated workforce needs, and to provide recommendations for how the institution(s) may better align programs to meet these needs.

2020 Perkins Guidelines

Overall, H.R. 7617 provided a \$716 million increase for education programs and \$254 million increase for federal workforce programs over FY 2020 enacted levels. More specifically, the Perkins Basic State Grant received an increase of \$18 million, or 1.4%, over the FY 2020 enacted level, bringing the proposed total to more than \$1.3 billion.
